



Daun Scholarship Fund

Background:

The Daun Scholarship Fund was established in 1991, following the passing of Dorothy (Mortimer) Daun. A lifelong Chilton resident, Dorothy married Elmer Daun in 1933 and together they raised 5 children. Dorothy was very involved in the community, working as the food service director for the school district, the secretary at the elementary school, and as a member of the Chilton's Women's Club. Elmer worked at the Carnation Company for 41 years, retiring in 1965. Elmer was also active in the Chilton community, serving as both a Chilton city alderman from 1948 to 1962, and mayor from 1962 to 1963.





Their first-born son, Kenneth, married Rosemary (Beyer) Daun in 1954. Together they had four children before he preceded Rosemary in death in

1961. Kenneth was a state highway commission engineer and a member of the Chilton Athletic Club. Rosemary was an engaged member of the community in Chilton, working as a colorist at Schabach Photography Studio, an office clerk/receptionist for Dr. James Knauf, and at Chilton Metal Products and Aluminum Specialty (Foley) until her retirement. She volunteered countless hours sorting through treasures for The Shepherd's Attic, and as a social individual, Rosemary was an integral part of the formation of the Chilton Red Hat Society.

The Daun family has been proud to offer this scholarship for Chilton students for over 30 years and with ongoing support from 3 generations, will continue to do so in perpetuity.

Eligibility: (taken into consideration to determine recipients)

- Graduating seniors from Chilton High School.
- Planning to attend an accredited 2-year or 4-year college or university, or a technical school, as a full-time student
- Demonstrates the following: Involvement in extracurricular activities, ambitious student, excellent social skills, good character, leadership skills, positive work ethic and strong sense of community
- Minimum cumulative 2.8 GPA
- Financial need will be considered

Award Amount:

One \$1,000 non-renewable scholarship, payable the first semester of college.

Selection

Recipients will be recommended each spring by Chilton High School Scholarship Selection Committee.

Collecting the Award & Payment Procedure:

Recipients must fill out and submit Scholarship Acceptance Form and Scholarship Verification Form through the Scholarship Portal (https://www.grantinterface.com/Home/Logon?urlkey=cffvrscholar). Recipients are required to provide supporting documents as instructed in the Scholarship Verification Form, such as class registration/list with credits listed, proof of major, grade transcript, etc.

After approval of online Scholarship Verification Form, the scholarship check will be paid directly to the school the recipient will be attending. The **Community Foundation communicates with students via email**; it is the student's responsibility to keep their Scholarship Online Portal account updated with their current email address.

Loss of Eligibility:

Failure to register as a full-time student for the first semester of the freshman year of college.
